FAA Record Review & Case Preparation

- Second Class: \$600 per year

Combined VA and FAA Standard Claim Service

Any request for ongoing assistance after 24 months from the start of service will require a new service payment at the current rates.

HIMS AME Services (Substance Use and/or Antidepressant Certification)

If you have a history of alcohol or drug related events, have been directed by the FAA to participate in the HIMS program, or are seeking FAA medical certification while taking an FAA-approved antidepressant medication, you need the guidance of an experienced Senior HIMS Aviation Medical Examiner (AME).

Wingman Med provides a comprehensive HIMS service that combines remote consultation with in-person FAA examinations and ongoing case management throughout the certification process.

Our HIMS services include:

- Initial remote or in-person consultation (\$350–450)
- Development of an individualized FAA certification strategy
- Assistance locating qualified neuropsychologists and psychiatrist evaluators
- Coordination of FAA-required monitoring, including abstinence testing when applicable
- Coordination with evaluating clinicians throughout the certification process
